 4. **If I Do Not Work The Required Hours, Crafts Unlimited Has My Permission To Deduct The Applicable Fee From My Sales.**
 5. I Understand And Agree That My Application Is Sent For Consideration, And Is Not A Guarantee Of My Entry Into The Show.
 6. **I Understand And Agree That My Entry Fee Is Non-Refundable, Unless I Am Not Accepted Into The Show.**
 7. Crafts Unlimited Shall Have No Liability For Any Lost, Stolen Or Damaged Merchandise.
